Uniform Update

- K. Priestap presented. Going with Dunny's as our suppliers. Have 6 options for jerseys, and jersey selection will also determine what we do with the hat selection. Planning to stay with grey pants.
- D. Grasby asked if we can get the jersey with the 2 buttons. J. Anotonio stated that any of the designs can be done with any style. J. Anotonio confirmed the material will be similar to last year. J. Paola stated that whatever logo we stick with should be the one we stick with for additional swag.
- J. Paola made a motion to go with the jersey option on page 2, with 2 buttons, for the 2025 season. 2nd by B. Mathieson. All in favour, Carried.

Will have a fitting night the end of January, that will likely be done at the Army Navy.

Hats for next year will be a full-back.

Coaches Update

Sponsorship, coaches are responsible for finding their own sponsors. Will need sponsors by mid-January.

Kyle has reached out to most coaches. Because so many coaches already have jerseys, they will have the option of getting the 2 jerseys, or getting a coat instead. ¾ style doesn't have the hood. Coaches can do the fitting the same night they do the jersey sizing.

Tournament Update

Most tournaments full, but 8U so far have 4 teams registered. Most teams are all paid up, haven't had to chase.

Have applied to host the 18U OBAs, and that decision will be made in January.

ICBA

D. Grasby stated that they voted on having a 22U T2 loop, denied. Have to get an alias link for OBA put on our website so that any complaints, harassments, ejections, etc. can be reported. \$300 per team for the alias website. \$205 per team also for OBA fees. \$8 per player and coach for insurance. \$75 per team for the banquet. Our association, not including insurance, have to pay between ICBA and OBA \$580 per team. Hoping to have, with intercounty all star teams, getting uniforms every year. Associations have to put

Rule changes for ICBA have to be put in by January. Will need to send requests to Emily by December 31st, and will vote on them at the January meeting.

Barry will be in charge of interlock teams for ICBA. Will be enforcing double-headers if having to travel far distances, of they have to come to us twice.

M. Francis asked if there has ever been any discussion about not tiering out a division. B. Mathieson stated that for teams who have a limited number of teams in a certain loop, they will be given the option.

Have to classify 5 days before your first OBA regular season game. Can go up later on, but you can't go down.

- K. Priestap asked if you can classify lower if we are classified at a certain division based on households.
- M. Francis asked if there's been a change to qualifications. It was confirmed that was voted down.

Rule change that if the coach declares last batter, their pitch counts won't interfere with subsequent games.

- M. Francis asked if we can be forceful on getting Packham for free. A. Mathieson stated that C. Redfern is working on that. M. Francis suggested St. Al's to run blastball. Discussed that we should reach out to the school board to see about getting St. Al's diamond for blastball. M. Francis asked if coach pitch is even

worth it, or if they should transition from blastball to pitching machine. It was discussed that this should be left to the house league committee.
