B. Hawley called the meeting to order.

B. Hawley declared conflict of interest on PFTA situation (Agenda Item #16).

Motion to approve agenda.

Moved by Barry Grasby, seconded by A. Mathieson. Carried.

Motion to approve the minutes from the meeting dated December 10, 2019. Moved by J. Brightwell, seconded by Brian Grasby. Carried.

Business Arising from Previous Minutes:

Motion to approve the minutes from the meeting dated December 10, 2019. Moved by C. Bridges, seconded by D. Graff.

Budget

Operational: The Finance Committee met and found a deficit of -\$2,400. Discussion on how to make up for that - fundraising, promoting house league, hosting tournaments.

Home tournaments made up for significant revenue in 2019.

Motion to approve 2020 budget and improve sponsorship revenue and tournament revenue to combat deficit.

Moved by Brian Grasby, seconded by J. Brightwell. Carried.

Capital Budget:

Motion that we have a guideline that we spend no more than 20% of surplus (bank draft) on capital projects each year.

Moved by J. Brightwell, seconded by M. Hall. Carried.

Motion to bring scoreboard monies out of capital and into sponsorship/fundraising. Moved by J. Brightwell, seconded by A. Mathieson.

Motion to formalize shed and tractor into capital for 2020, and hold balance in reserve for future capital projects that may come up.

Moved by J. Brightwell, seconded by Brian Grasby. Carried.

Potential capital projects: dufferin backstop, irrigation at dufferin, and cement at SERC dugouts.

Fundraising/Sponsorship

B. Hawley explained that the Fundraising Committee came up with a few sponsorship ideas for banners to be hung at the stadium and Dufferin Park. Plan is to have 2 sponsorship options: \$290 for a one year sponsorship banner, \$600 for a 3 year sponsorship banner - banner is always owned by the sponsor.

Motion to have 2 banner sponsorship packages:

- 1. \$290, one-year sponsorship sponsor keeps banner.
- 2. \$600, three-year sponsorship sponsor keeps banner.
 - a. 4x8 banner, 2 colour.

Moved by Barry Grasby, seconded by A. Mathieson. Carried.

Discussion on how to promote House League. J. Brightwell suggested we try to promote HL in May, like a clinic for parents to bring their kids out to see if they like baseball.

Action Item: A. Mathieson to email school board to ask if we can make up a HL poster and have principals hand out at schools to promote HL baseball.

Taco night: Jay Ford requested that we have Taco Night in April.

Motion to have Taco Night on April 7th and 21st. Moved by Barry Grasby, seconded by M. Hall. Carried.

Action Item: Barry Grasby and B. Hawley to meet with Jay Ford and decide who is printing tickets. (Update: C. Redfern had Pat Kelly of PK Design create tickets, and Business Centre to print and cut them so they are ready for coaches meeting.)

Motion to have coaches meeting this week to hear about Taco Night changes. Moved by Barry Grasby, seconded by M. Hall. Carried.

Action Item: D. Graff to organize coaches meeting this week to hear about Taco Night changes. (Update: meeting is scheduled for Wednesday February 19, 2020).

Registration Update:

C. Redfern updated that 62 rep kids have registered as of February 10th, 2020. 52 have paid. 26 HL registrations - 23 have paid. 3 blast ball registered. 9 rep players have paid the full \$450

Action Item: C. Bridges to contact 9 parents for reimbursement.

Action item: Board to find two more house league convenors.

Umpires Update:

B. Hawley informed that the umpires committee was able to stay under the \$5,000 allocated budget for umpiring (\$4,400). Refunding the registration fee after they've umpired their 5th game for SMBA. S. Vaters mentioned UIC needs to make sure it's not after they've been scheduled 5 games, rather after they've completed 5 games.
