# 6. Fundraising Committee: Brian Hawley

a). Summertime Bash slo-pitch tournament date set for July 20<sup>th</sup>. Brian Hawley has ordered the alcohol and applied for the liquor licence. Letters to City are all done. Another meeting is being set up to discuss prizes. Security is booked. Coaches were once again reminded NOT to schedule any tournaments or games for that weekend.

Recommendation was made to look into a Debit Machine (POS system) for SMBA to use at the hitman tournament and registration nights. We can also rent it out to other organizations. K to get details and report back to the board. Treasurer given authority to go ahead if cost is reasonable. Will report at next meeting.

Corey mentioned that we should get a separate bank account to use it with, especially if we are renting it out to other organizations.

## 12. Facilities/Equipment Committee: Steve Vaters/Barry Grasby

- a.) SMBA Lawsuit:
  - a. Woman suing SMBA and city for a fall in 2011
  - b. Cathy Graver was president and will be attending a discovery meeting
  - c. Jeff, Steve and Dave are helping with it. Conference call with lawyer
  - d. Insurance company through OBA is covering all costs
  - e. Amy, due to the experience in insurance industry reminded ALL coaches that injury forms MUST be completed after ANY injury at a ball park during game or practice. This includes spectators. K reminded everyone that these forms are posted on our website.
- b.) Equipment Surplus donation Barry and Brian. Held up currently.
- c.) Steve is ordering a first aid kit for all team bags
- d.) City was contacted by the Ontario Electricity safety inspector. Complaint was filed by an anonymous person regarding the stadium. They now have to inspect the Stadium. City will let us know the outcome. It will happen late in Spring.
- e.) Dugout Roofs are now on at Dufferin. Dave to ask city if we can put mesh on the sides.

# 13. Coaches Committee: Dave Graff

- a.) We are running 5 clinics. Saturdays starting March 24<sup>th</sup>. Tom to call OBA and book them. Initiation Module, Infield Clinic, Hitting, Teaching, Pitching and Catching
- b.) Dave has list of NCCP numbers. It is the responsibility of the coach to determine what they need. OBA will not longer share that info with SMBA.

a). Hawley - Pitch, hot and run. Brian wants to bring it to Stratford. We have had some success in Stratford. Brian has been talking to MLB "Junior Home Run Derby". U14 competition. No cost. Use a little league stadium. Dufferin - can move plate. Can set up any distance. Winner goes to regionals in Philli and Chicago. Could be a good fundraiser. Pitch hit and run has regional comp at Rogers Centre. All are 7 - 14. They have each individual age groups. Home Run derby has to happen in May. Pitch hit and run is in Toronto. More realistic. No downside beside volunteers. HOF likes to run it due to promotional. Local, Regional, Rogers Centre, 7:00 am on a Saturday am.

Barry thinks we are stretched for volunteers – especially since they are mostly coaches. Weekends are already taken up by other events (Mega tournament, Hitman, etc.) May be tough to plan so late. Brian will put something together for our March Meeting

b). Minor Peewee T2 – Team not made yet. Have had 5 tryouts. One release to make. 12 players.

c). House League Jr. Rookie Fees. Dave brought up discussion of lowering fees for Jr. Rookie HL. Allan Wilker (HL Rep) reported that he has not had any complaints about the fee. Emily commented that these players are wanting to move up to mosquito anyway. We need a convenor to run this league and figure this out. Board decided to keep the fees the same.
